MEDICOLEGAL EXPERIENCE

I have been preparing medical reports since 1996 as a Registrar, Senior Registrar and Consultant. I undertake about 600 reports per year. I also undertake medical negligence reports and have been doing so now for the last 7 years and undertake 70 to 100 reports per year. My instructions are split about 50% claimant, 30% defendant and 20% single joint instruction. My waiting list for appointments is about 2 – 3 weeks. The completed reports are returned to the instructing party within 1 week.

I have been to court on between 10 to 15 occasions. These attendances were to provide factual information or expert evidence and opinion.

I have also been to court as an independent expert instructed by the Coroner.

I also undertake low velocity impact reports.

PUBLICATIONS

I have published a BSc Thesis, *17 peer-reviewed articles* in a number of respected international journals, *17 abstracts* following presentation of papers at various meetings around the world and a number of invited articles including book chapters. I have on-going research studies on various aspects of Orthopaedics and Trauma.

I have presented my research papers at *30 formal meetings worldwide* including a number of prestigious international meetings, which have also included a number of prize nominated and winning presentations. I am regularly invited on to the faculty at Orthopaedic meetings and Medico-Legal courses.
